CSR (Corporate Social Responsibility) Area

- Continue and strengthen activities focusing on priority topics in order to;
 - provide information exchange platforms for member companies
 - facilitate the dialogue between Japanese companies operating in Europe and European Institutions
 - develop a close dialogue with other key CSR players both in Europe and in Japan

- Priority topics
 - Reporting and Transparency, Supply Chain Management
 - EU-Japan Best Practice Comparison
 - Gender Diversity, Stakeholder Dialogue
 - Other topics including Demographic Change, CSR Trend in EU, Social Responsibility Investment, Sector-based CSR issues

Trade Policy Area

- Analyse issues and communicate with policy-makers in corporation with European/ Japanese industrial organisations in order to activate discussions and studies with competent European authorities achieving EIA (Economic Integration Agreement) between Europe and Japan

- Monitor and take appropriate actions for issues of interest to our members including:
 - ITA (Information Technology Agreement) development
 - Customs classification
 - Logistic issues such as Authorised Economic Operators, and
 - Other EU's international trade policies such as IPR (e.g. counterfeit, IP related agreement) and FTA strategy

Information Society Area

- Monitor and take appropriate actions for personal data protection regime, especially for the international data transfer issue

- Monitor IP related issues such as copyright levy policy and scheme in EU

- Promote activities related to ICT for Energy Efficiency in collaboration with relevant organizations
- Monitor overall and specific ICT related EU policies such as RFID technology and application, e-Government, e-Health
- Strengthen Cooperation and possible collaboration with other organisations in Europe and in Japan

Standards and Conformity Area

- Monitor and study European/ International standardisation and conformity processes for environmental relating issues, especially RoHS and EuP/ErP (Eco-design) directives
- Monitor and study (and if necessary, participate actively) the harmonised market surveillance

Consumer Policy Area

- Monitor major issues in EU consumer policies, including Consumer Rights Directive and collective redress

Corporate Policy Area

- Issue “JBCE Report” as a comprehensive proposal of JBCE, which contains issues regarding corporation laws, taxation, human resources as well as issues discussed in committees of relevant areas.
- Monitor and assess the impact of EU policies related to corporate activities including:
 - Tax-systems of EU and Japan regarding international transaction
 - Corporate laws
 - Data protection
 - Harmonisation of Resident/ Work permits for Intra-corporate transferees
 - Competition policy
 - Provide position papers and input to relevant bodies including the European Commission
- Communicate with the European Institutions and other European/ Japanese associations in order to facilitate the above mentioned activities, such as EU-Japan Business Round Table
